# Introduction

Smart governance: This new wave of “smart governance” implies more inclusive and participatory processes in decision making but not only through ICT (online consultations, votes etc.)

**Co-construction process of policies with public institutions, private organisations and civil society to build a long-term strategy for their territory.**

Smart governance is a more than relevant issue for mountain areas:

- Because of geographic constraints
- Because mountain areas gather many different sectors and interests.

**Issues addressed:** integrated governance, smart regional development (beyond administrative borders), recognition of the potential of mountain areas

### **Governance model:**

- 9 Massif Committees
  - 18 members: local & regional institutions, stakeholders managing resources (forests, water etc.), environmental organisations, representatives from all relevant sectors (agriculture, tourism etc.)
  
- 1 National Mountain Council
  - Chair: Prime Minister of Romania
  - Presidents of the 9 Massif Committees
  - Representatives of Ministers

# Massif Committees

## Romania

### **Massif Committees:**

- Collaborate with local stakeholders, associations, businesses, LAGs, universities etc.
- Divide into technical committees for each topic
- Provide local expertise
- Develop relevant policy recommendations

### **Outcomes & successes:**

Integration of all sectoral issues at the most relevant territorial scale

Based on French successful model (participation in shaping regional policy & designing OPs).

Ability to convene the National Mountain Council to be clarified

# GAYA - Governance and Youth in Alps

## Alps



**Issues addressed:** Involving young people in public life & encouraging generational renewal

**Governance model:** Tailor made, Youth participation processes should not be a one-day event, but a spiral-shaped, never-ending process.

Be clear about what can and cannot be influenced. Be transparent, honest, and clear about the purpose, the limits of what can and cannot be influenced, and what can happen as a result.

Feedback, feedback, feedback.

# GAYA - Governance and Youth in Alps

## Alps



**Outcomes & successes:** There is actually no such thing as ‘the youth’.

While young people do not necessarily engage in party politics, they are (often politically) active on social media and in diverse cultural, sport and social organizations. Young people are very much interested in societal challenges and international matters.

**Resources needed:** Around 1 million €, all tools available online

## Alps

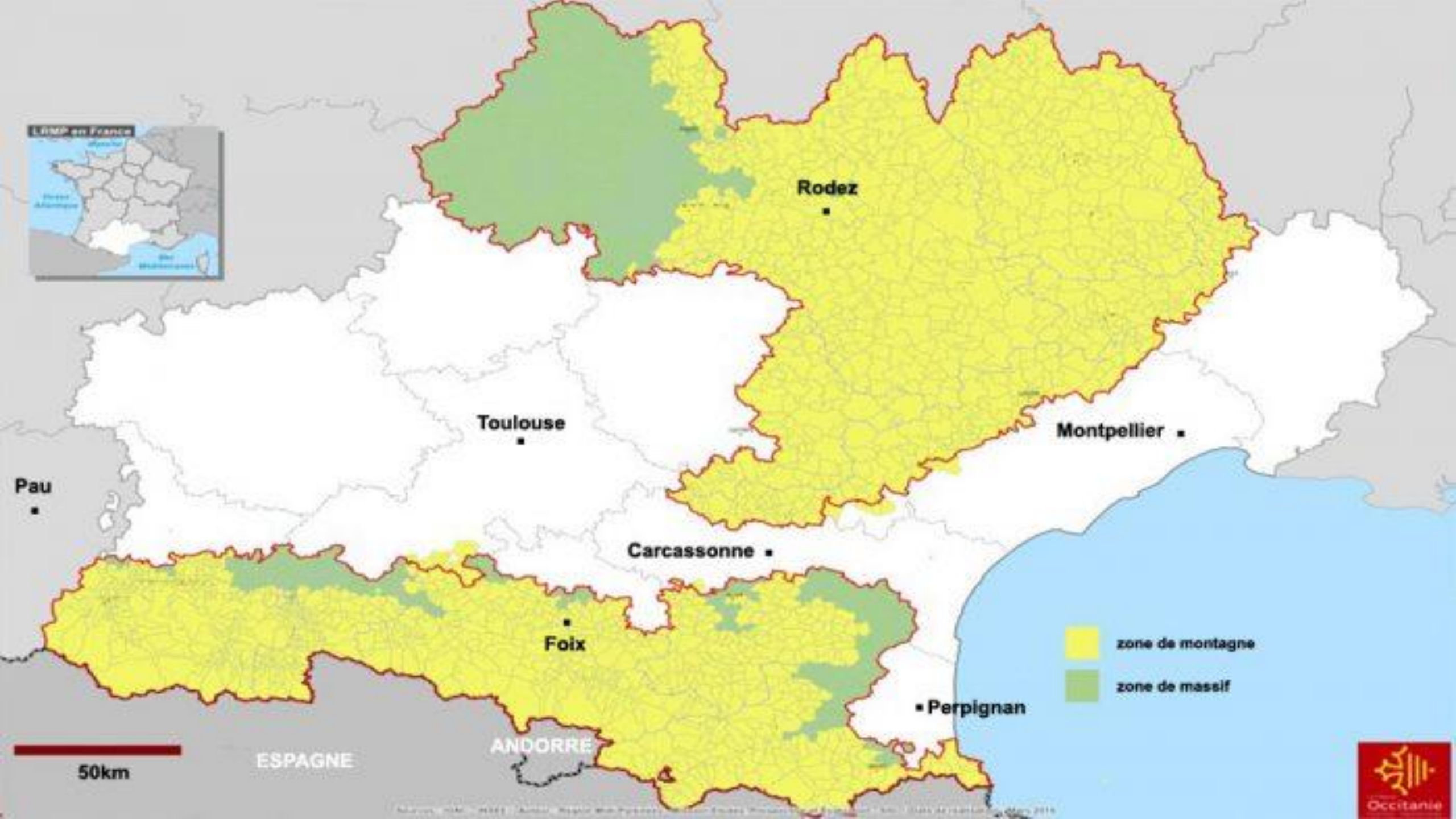
**Extra info:** One of the project's outputs is the creation of a [Tool Box targeting policy makers and administrators](#). The Tool Box offers:

- a guide to fight stereotypes about the youth and politics and explaining how to listen to the youth

# Mountain Parliament Occitanie - France

**Issues addressed:** population participation to public policies, focus on all sectors, attention to mid-mountain areas

Creation 2018

## **Governance model:**

- Online opened platform – 700 members
- Plenary sessions (2x / year)
- Collective projects for 2019:
  - Making seasonal employment more secure
  - Including mountain storytelling in touristic marketing
  - Promoting non-foods Geographical Indication to maintain value in the area

# Mountain Parliament Occitanie - France

## Governance model:

No binding effect

Mountain local think tank

Different from Massif Committees

## Outcomes & successes:

- Collaboration of the “renewable energies” group with the Regional Agency for Energy & Climate to write the part on acceptability of the Mountain Plan
- Launch of a participatory budget Mountains of Occitanie, lands of life and innovation with a 1,2 million euros budget 2019/2020

# Mountain Parliament Occitanie - France

## Outcomes & successes:

- Members: 50% civil society, 50% public institutions
- More than 150 participants for the Mende plenary session in April 2019

## Resources needed:

- 2 officials from the Region from the Directorate for Territorial Development + connections with other services for content related issue
- 60.000 – 80.000 euros / year

# MEDstrategy - Governance in MED areas

## Teruel - Spain

**Issues addressed:** MedStrategy project aimed at improving and address territorial governance of Med rural areas towards sustainability through an innovative integrated Planning Model (PM). The process focuses on 3 themes:

1. the integration of economic, social, environmental dimensions of sustainability in planning;
2. the development of integrated & shared strategies and actions through the cooperation of local authorities and the engagement of local communities for the innovation of territorial governance;
3. the setting up of common objectives & activities for local and transnational synergies of rural areas.

**Governance model:** Strategic planning with stakeholders discussion implemented in 4 pilot territories.

# MEDstrategy - Governance in MED areas

## Teruel - Spain

### **Outcomes & successes:**

- 4 Strategic plans
- Training courses to provide opportunities for learning and getting qualified experts and improving the involvement of local community through training.
- Pilot action of implementing self-employed agriculture and livestock farming (Result of 13 farms of focus on sheep breeding)

**Resources needed:** Around 1 million € and deliverables available online

# MEDstrategy - Governance in MED areas

## Teruel - Spain

### Extra info:

- Teruel's topic Re-introduction of ranching activities - ovine/goats- in villages of Teruel where the activity has been important in the past but has now decreased or disappeared
- Italy (Tindari-Nebrodi) and Malta focus on tourism
- Crete focus on agrifood promotion
